Application Fee	\$65.00 per child (due with application, not refundable)
Textbook/Uniform Fee	\$835.00 per child (due at time of acceptance, not refundable)
Processing Fee	\$2,000.00 per child (due at time of acceptance, not refundable)
Enrollment Fee	\$400.00 per child (due with enrollment, not refundable)
Tuition Fee	\$9,000.00 per child (one-time payment due August 1st, or two-time payment due August 1 st and January 1 st , not refundable)
TOTAL COST	\$12,300 per child

HOUSING OPTIONS: Housing is **NOT** included in the above fees. Parents may use an outside housing company to secure housing and transportation. OR, there is an option to house your student with an ACS approved person/family for **\$6,000** for the school year. If this option is chosen, then the fee will be due and payable to ACS on August 1st. This fee is in addition to the fees listed above and is not refundable.

TUITION PAYMENT: ALL Payments must be made either by wire transfer or from a state-side account through FACTS Tuition Management. This payment along with the Tuition Payment Enrollment Fee will be set up during the Enrollment/Re-enrollment process each year.

AFTERCARE: Fees charged monthly or hourly

Aftercare is available when school is in session for student's 9th – 12th (Secondary) grades, from dismissal until 6:00 PM, billing begins at 4:00 pm Monday - Thursday and 4:00pm on Friday. Monthly fees must be prepaid by the 10th of each month through FACTS. For those not enrolled in the aftercare monthly payment plan, each student will be billed hourly. Hourly billing must be paid at the close of each week. Payments must be made through FACTS, separate from your tuition payment.

PAYMENT POLICY DETAILS:

1. Any account that is ten days past due will result in the student not being permitted to class each day after until the account is satisfied. (SPECIAL NOTE: financial accounts must be current at time of quarter and semester exams or students may not be allowed to take those exams.)
2. Enrollment fees, textbook fees, materials/facilities fees, and tuition ARE NOT SUBJECT TO REFUND. The Textbook fee is a RENTAL fee; you will be charged full cost to replace any lost books and a fair fee for any damaged materials.
